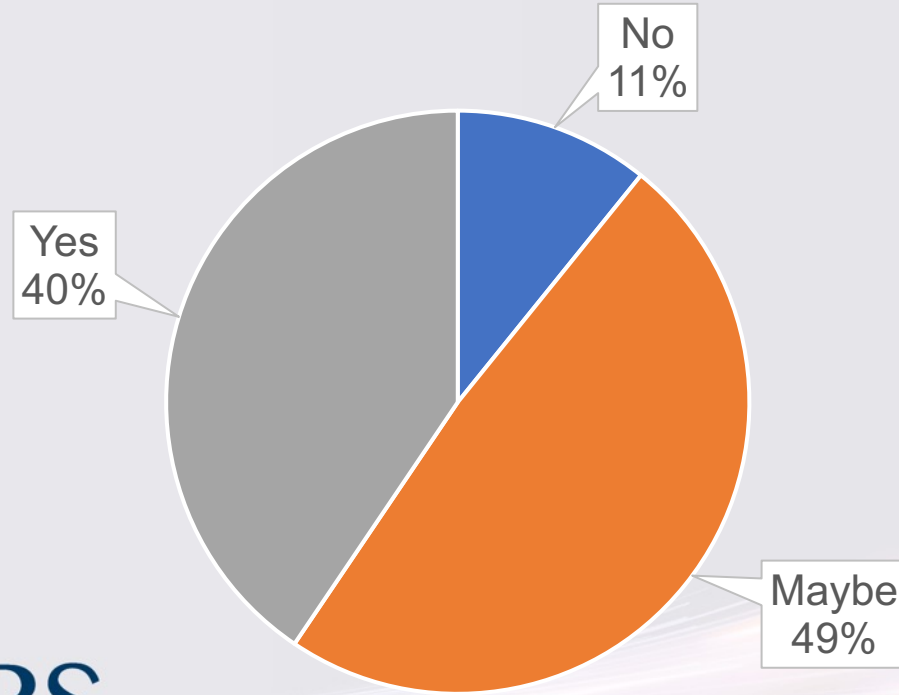




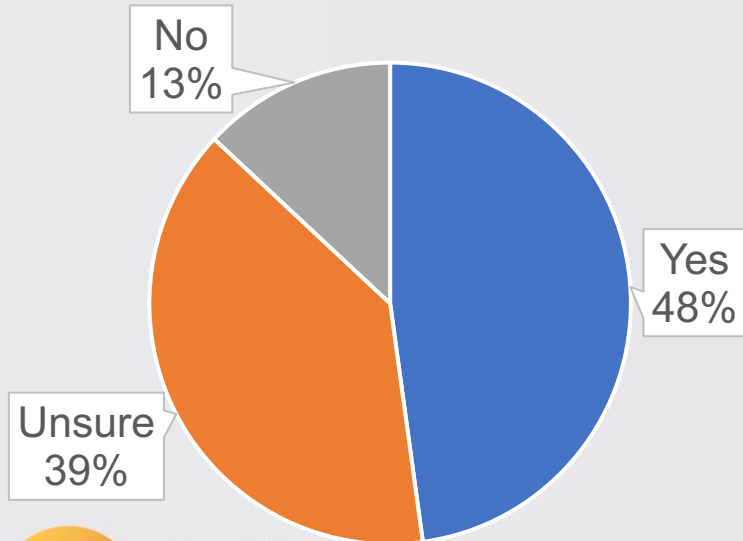
# Are you aware of your country's regulatory or governing agency's regulation pertaining to diverse clinical trial enrollment? i.e. FDA

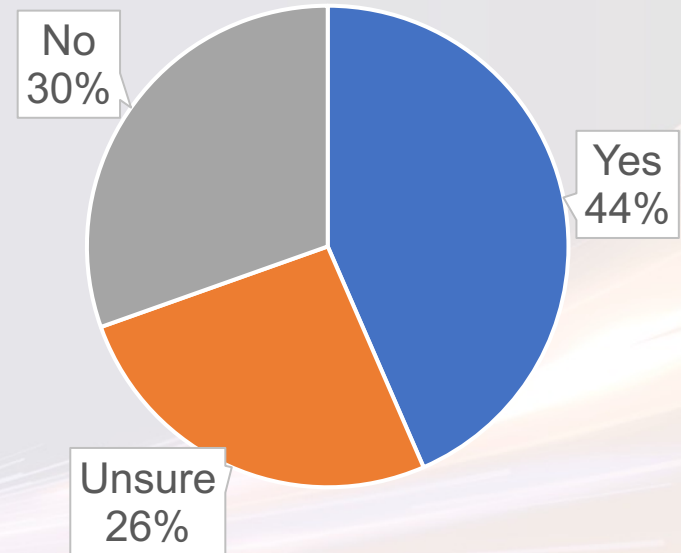
# Do you believe that this guidance helps diverse enrollment into clinical trials?



Do you perceive that recent regulatory guidance, laws, or regulations affects you and your business?

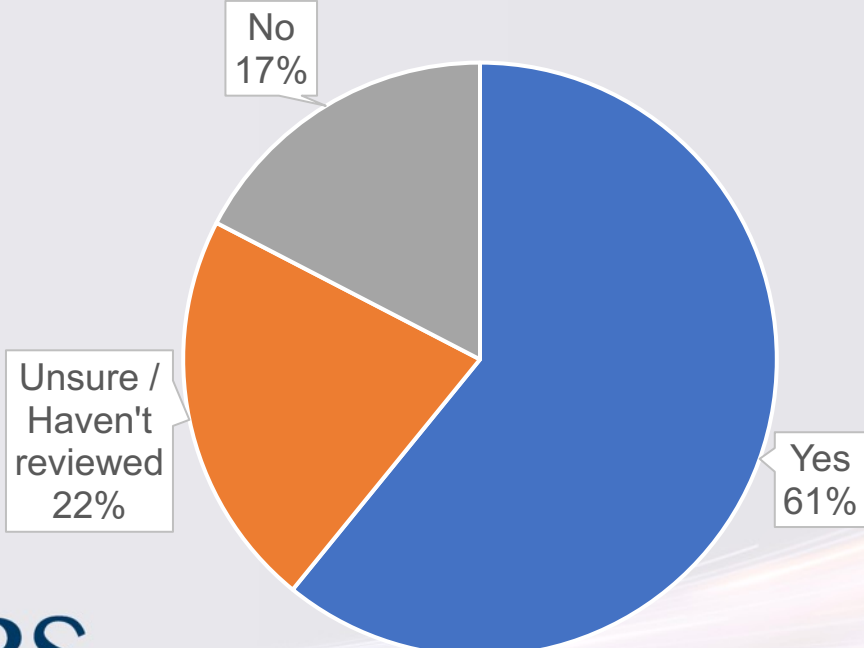


Are you planning to modify your business and operations to address increasing diversity related trial requirements?





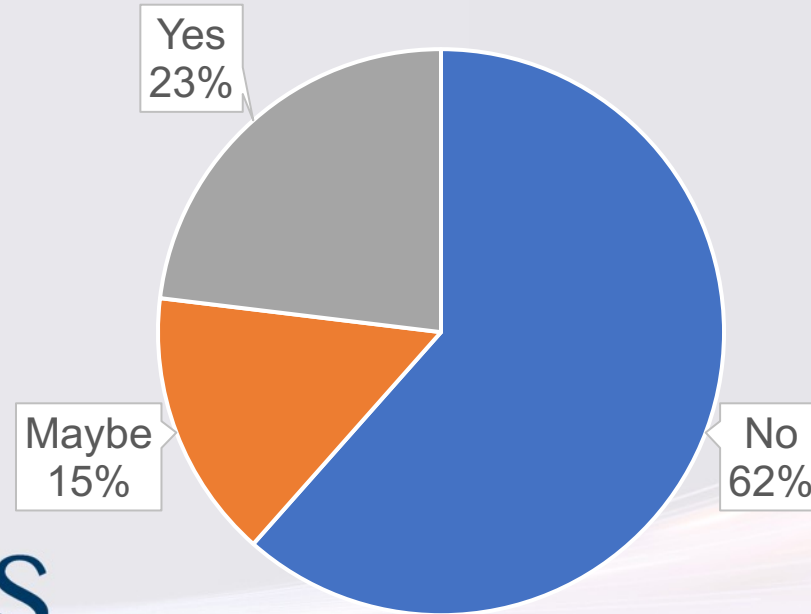
Do you observe that your site is successfully representing diverse, equitable, and inclusive patient populations as you enroll your current portfolio of clinical trials?

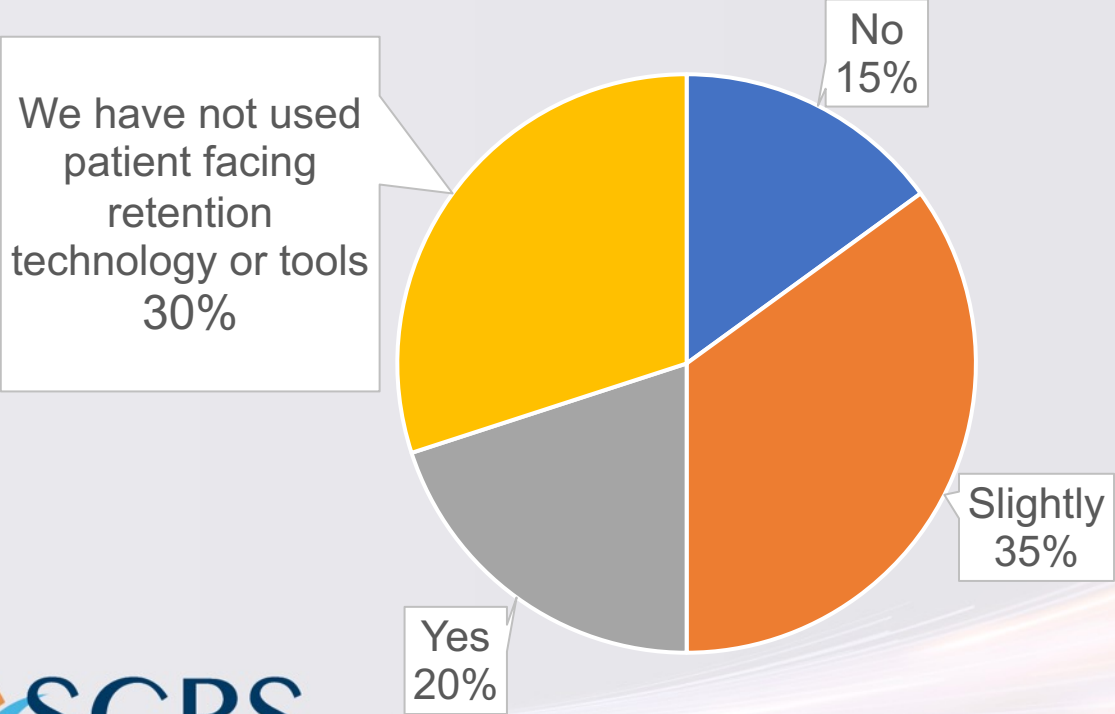

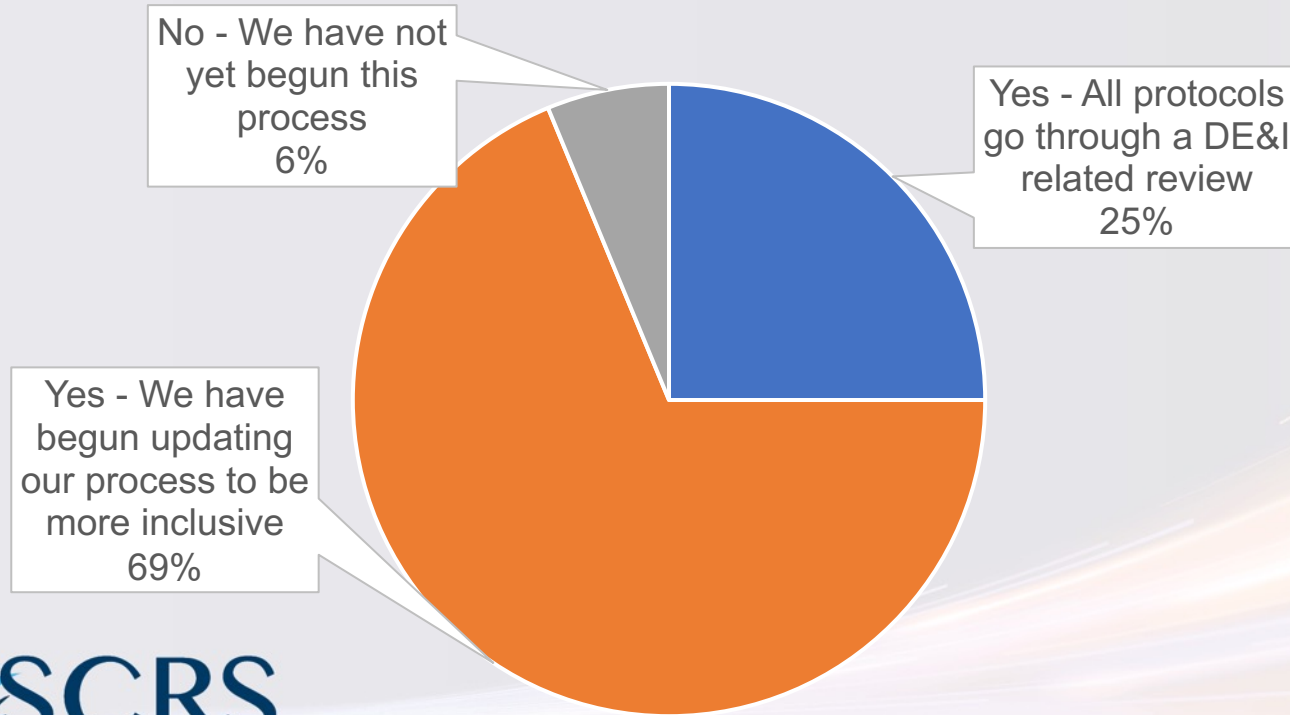
